AN ORDINANCE

BY TRANSPORTATION COMMITTEE

**AN ORDINANCE TO AMEND THE 2000 (AIRPORT RENEWAL & EXTENSION FUND) BUDGET BY TRANSFERRING TO AND FROM APPROPRIATIONS THE AMOUNT OF \$2,424,685.50 FOR THE PURPOSES OF REFUNDING THE AIRPORT NOISE MITIGATION PROGRAM FOR THE SALE OF LAND ORIGINALLY ACQUIRED WITH GRANT FUNDS ISSUED BY THE FEDERAL AVIATION ADMINISTRATION AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta owns and operates the Hartsfield Atlanta International Airport; and

**WHEREAS**, the Airport Noise Mitigation Program on behalf of the Hartsfield Atlanta International Airport acquired various parcels and its adjacent land totaling 33.532 acres with grants issued by the Federal Aviation Administration (FAA); and

**WHEREAS**, the City of Atlanta, Department of Aviation and the City of College Park, Georgia entered into a Master Land Agreement providing for College Park to acquire, maintain and develop said 33.532 acres with financing to be provided in the form of a note given by College Park; and


**WHEREAS**, an Intergovernmental Agreement and Land Repurchase Agreement have now been executed and provided for the City of Atlanta to repurchase said 33.532 acres, and receive a credit in the amount of \$2,424,685.50 (33.532 acres x \$72,309.60) at Phase I of the closing of the Intergovernmental Agreement with the City of College Park in settlement of the original amount due the City of Atlanta; and

**WHEREAS**, the FAA (ACR Order 5190.6A) stipulates that it must approve the use of proceeds acquired from the sale of land which was obtained with FAA grant funds; and

**WHEREAS**, the Airport Renewal & Extension Fund Reserve for Appropriation has been identified as the source of funds to reimburse the airport cost center (Property Disposition Proceeds, Grant Program) of which said proceeds must be appropriated.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS AS FOLLOWS:**

**SECTION 1:** That the 2000 (Airport Renewal & Extension Fund) Budget be and hereby amended as follows:
