A SUBSTITUTE ORDINANCE

BY TRANSPORTATION COMMITTEE

A SUBSTITUTE ORDINANCE AMENDING THE 2000 (AIRPORT RENEWAL & EXTENSION FUND) BUDGET BY TRANSFERRING TO AND FROM APPROPRIATIONS THE AMOUNT OF \$16,000,000.00 TO PROVIDE FUNDING FOR THE ARCHITECTURAL & ENGINEERING PLANNING SUPPORT SERVICES CONTRACT (FC-7216-00); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta has undertaken a capital improvement program to facilitate major expansions and improvements at Hartsfield Atlanta International Airport in accordance with the new Airport Master Plan; and

WHEREAS, the City is entering into Contract FC 7216-00, for Architectural & Engineering Planning Support Services necessary to facilitate construction of various airfield, terminal, concourse, roadway, and related support facilities at the Airport; and

WHEREAS, it is now necessary to amend the 2000 Airport Renewal & Extension Fund Budget to appropriate funds for said Contract.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

Section 1: That the 2000 Airport Renewal & Extension Fund Budget be and hereby is amended as follows:
