**AN ORDINANCE AUTHORIZING THE MAYOR OR HIS
DESIGNEE TO EXTEND THE TERM OF THE EXISTING
INTERIM TELECOMMUNICATIONS FRANCHISE
AGREEMENT BETWEEN THE CITY AND NEXTLINK
GEORGIA, INC., FOR THE PROVISION OF
TELECOMMUNICATIONS SERVICES USING THE
PUBLIC RIGHT-OF-WAY, AND FOR OTHER PURPOSES.**

WHEREAS, the City has entered into an interim telecommunications franchise agreement with NEXTLINK Georgia, Inc., which provides telecommunications services on, under, over and through the public rights-of-way the City; and

WHEREAS, this agreement will terminate at midnight on June 30, 2000; and

WHEREAS, it is in the best interest of the City to extend the agreement for a period of six (6) months, to and through December 31, 2000, pending the enactment of a comprehensive ordinance governing the use of the City's rights-of-way pursuant to the 1996 Federal Telecommunications Act;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

- SECTION 1: That the Mayor or his designee and is hereby authorized to execute an agreement to extend the interim telecommunications franchise agreement with **NEXTLINK Georgia, Inc.**
- SECTION 2: That such agreement extend the existing interim franchise agreement for a period of six (6) months, to and through December 31, 2000
- SECTION 3: That the City Attorney shall prepare an agreement providing for such extension, and that such agreement shall not be binding on the City until approved by the Mayor or his designee and delivered to **NEXTLINK Georgia, Inc.**
