



A RESOLUTION AUTHORIZING THE SETTLEMENT OF ALL CLAIMS RESULTING FROM THE CASE OF UNIVERSAL UNDERWRITERS V. CITY OF ATLANTA, STATE COURT OF FULTON COUNTY, CIVIL ACTION FILE NO. 98VS0139138J, FOR \$1,000; AUTHORIZING THE CHIEF FINANCIAL OFFICER TO DISBURSE THE SETTLEMENT AMOUNT; AND FOR OTHER PURPOSES.

WHEREAS, Universal Underwriters v. City of Atlanta, State Court of Fulton County, Civil Action File No. 98vs0139138J, is a case in which the City of Atlanta is named as a Defendant;

WHEREAS, the Plaintiffs allege that on December 13, 1994, a City of Atlanta police officer lost control of his police cruiser and collided with a fence owned by Southeastern Automotive Warehouse (Plaintiff's Insured) resulting in damage to property in the amount of \$2,970.00.

WHEREAS, the Plaintiffs have agreed to accept \$1,000 in settlement of all claims against the City of Atlanta;

WHEREAS, the City Attorney has done an extensive review of the facts and law and has determined that the City's potential financial exposure is far in excess of the settlement amount; and

WHEREAS, the City Attorney considers it to be in the best interest of the City to resolve this matter and recommends that the City pay the amount of \$1,000 to settle all claims,

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1. The City Attorney is hereby authorized to settle the case of Universal Underwriters v. City of Atlanta for the sum of One Thousand Dollars (\$1,000).

SECTION 2. The Chief Financial Officer is authorized to pay a total sum of \$1,000 to the Plaintiff in this case, from Account No. 1A101-529017-T31001.
