AN ORDINANCE TO PROVIDE FOR NO  
PARKING AND LOADING ZONE SIGNS  
ALONG BOLLING WAY, BETWEEN PEACHTREE ROAD  
AND PHARR ROAD.

WHEREAS, Bolling Way in Buckhead, between Peachtree Road and Pharr Road, has a high concentration of bars and nightclubs; and

WHEREAS, these bars and nightclubs are frequented by large crowds of people during weekends; and

WHEREAS, due to the sheer volume of people walking in the Bolling Way area in order to access these bars and nightclubs, a critical safety hazard for pedestrians has been created.

WHEREAS, additionally, during the weekday, vehicles that are loading or making deliveries and are parked in front of the bars and nightclubs on the west side of Bolling Way create a safety hazard for automobiles because these vehicles limit their visibility.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That "No Parking Between 9pm to 5am – Thursday to Saturday – Tow Away Zone" signs be installed on both sides of Bolling Way between Peachtree Road and Pharr Road.

SECTION 2: That "Loading/Deliveries Only Between 9am – 9pm – Weekdays - Tow Away Zone" signs be installed on the west side of Bolling Way between Peachtree Road and Pharr Road.

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.
