

The investigation determined that a contractor, Rockdale Pipeline, installing new sewer lines, failed to reconnect the claimants' properties to the City's mainline causing their sewer line to back up. The claimants have been advised to pursue their claim with Rockdale Pipeline. Furthermore, the claim as presented does not comply with the requirements of notice as set forth in O.C.G.A. §36-33-5, the six month statute of limitations expired prior to receipt of the claim.
