A RESOLUTION AUTHORIZING THE MAYOR TO APPROVE RENEWAL AGREEMENT NO. 1 FOR FC-6920-97, REINVESTMENT AGENT SERVICES WITH CHAMBERS, DUNHILL RUBIN AND COMPANY AND SALES, GOODLOE AND GOLDEN, A JOINT VENTURE FOR FC-6920-97, REINVESTMENT AGENT SERVICES ON BEHALF OF THE DEPARTMENT OF FINANCE.

WHEREAS, the City of Atlanta did enter into an agreement with Chambers, Dunhill Rubin and Company and Sales, Goodloe and Golden, A Joint Venture, FC-6920-97, Reinvestment Agent Services, and

WHEREAS, said contract contained an initial term of one (1) year with an additional one (1) year renewal option; and

WHEREAS, Chamber, Dunhill, Rubin and Company and Sales, Goodloe and Golden, a Joint Venture has performed the contracted services satisfactorily; and

WHEREAS, The Chief Financial Officer and the Director of Purchasing and Real Estate have recommended Renewal Agreement No. 1 for FC-6920-97, Reinvestment Agent Services;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to enter into Renewal Agreement No. 1 with Chamber, Dunhill, Rubin and Company and Sales, Goodloe and Golden, A Joint Venture for FC-6920-97, Reinvestment Agent Services; and

BE IT FURTHER RESOLVED, that the Director of the Bureau of Purchasing and Real Estate is hereby directed to prepare an appropriate Renewal Agreement No. 1 for execution by the Mayor, to be approved by the City Attorney as to form; and

BE IT FURTHER RESOLVED, that compensation for services rendered shall be amounts based on the following schedule:

Rebate situations less than 24 months "spend down", 3 basis points
Rebate situations more than 24 months, 4 basis points
Non-rebate situations, 1 basis point

BE IT FURTHER RESOLVED, that this Renewal Agreement No. 1 shall not become binding on the City and the City shall incur no liability upon same until such Agreement has been executed by the Mayor and delivered to the contracting party.
