**WHEREAS**, the Chief of the Department of Corrections and the Director of the Bureau of Purchasing and Real Estate recommend approval of said renewal agreement.



PROPOSAL FOR PROVIDING PHYSICIAN SERVICES FOR DETENTION CENTER; ATLANTA, GEORGIA FC-6849-97

**OBJECTIVE:** To provide health related services at the Jail, Department of Correction, Atlanta, Georgia.

**BUSINESS ORGANIZATION:** JAMES M. CRAWFORD, M.D., 2646 GRESHAM ROAD; ATLANTA, GEORGIA 30316. Operate as an individual, along with three nurses. Licensed to practice medicine in the State of Georgia.

**STATEMENT OF SERVICES TO RENDER:** To provide quality healthcare - perform required examination after offenders have been sentenced; screen individuals for sexually diseases, infectious or contagious diseases; screen individuals for Kitchen details; make referrals appropriately, and make recommendations to the Director concerning any medical-related problems affecting any inmate that I have direct responsibility for assessing; to caution workers of the necessity of keeping blankets and bedding clean; make appropriate referrals when necessary for the rehabilitation of alcoholics, drug, and other offenders. Additional, any problem with the physical plant that may affect the lives of the offenders assigned to my care, I am to inspect, to evaluate, and make recommendations for a possible solution.

**APPROACH AND SCOPE OF SERVICES:** To have a pragmatic and hands-on approach - review the medication orders and treatment plan for inmates from my Unit that are referred to Grady Memorial Hospital; to be available to hold adequate sick call Mondays through Fridays, except legal holidays; to provide sick call at an agreed time; provide proper medical attention and prescribe the appropriate medication; when not available to perform responsibilities, to arrange with a qualified doctor to cover; to be available for telephone and other consultations with the nurses 24 hours a day. Address each acute and pressing problem that may affect the well-being of the inmates; review the records of each sentenced offender that has been treated by the dentist, a referral service, nurse, or consultant. Examine and assess each newly sentenced offender; approve kitchen detail assignment; review any medication brought to the jail; assess the pregnant females, provide prenatal care; make recommendations to the Director on problems relating to pregnant offenders; attend relevant Seminars.

**PRIOR EXPERIENCE:** Have been providing Health Services for the Department of Correction since July, 1975. Assigned to the Key Road location until that facility was closed and then transferred to the down town location. I worked for the former Director, Mr. J.D. Hudson and am now serving under the present Director, Mr. Tom Pocock. Mrs. Virginia Ingram, Medical Coordinator, and Mrs. Frances Clark, Deputy Director have worked with me since 1975.

**FINANCIAL CAPABILITY:** Business financial resources are stable and sound. My required State Medical License and Malpractice Insurance are current and up to date. My continued Medical Education requirements are in order.
