Dear Ms. Mitchell:

I write today to ask your assistance in initiating the process of filing a claim for compensation.

On Friday, April 28th, 2000, I was involved in a car accident (copy of motor vehicle accident report attached) with an Atlanta police officer who was driving a city insured vehicle. I have obtained an estimate for repair to my car (also attached). Receipts for my initial appointment at The Emory Clinic, the cost for which was not covered by insurance, are also enclosed. The only additional expense I currently anticipate is for a rental car during the days my car will be in the shop for repair.

Although none of the investigating officers who came to the scene of the accident interviewed me to ask for my account of the events, they *only cited* the driver of the other vehicle, Maj. William B. Shannon. And despite his statement (with which I disagree) that I "came to a sudden stop" (I was stopped for oncoming traffic), I am apparently not being held responsible.

I would appreciate your contacting me within the next 10 business days to advise me of: [1] the procedure to follow for filing a claim and [2] what, if any, additional supporting documents you may require.
