**A RESOLUTION ACCEPTING THE REPORT SUBMITTED BY THE CITY OF ATLANTA ELECTED OFFICIALS COMPENSATION COMMISSION ON RECOMMENDATIONS CONCERNING COMPENSATION OF CERTAIN CITY OF ATLANTA ELECTED OFFICIALS, PURSUANT TO SECTION 2-703 OF THE CITY CHARTER.**

**WHEREAS**, the City of Atlanta Elected Officials Compensation Commission has been established pursuant to section 2-701 of the City Charter; and

**WHEREAS**, the Commission must make its recommendations to the Council and Board of Education on the amount of compensation which it deems appropriate for the Mayor, President of Council, members of Council, and members of the Board of Education by not later than November 6, 2000, at least one year prior to the next regular municipal election as prescribed in Section 2-703 of the Charter; and

**WHEREAS**, the Commission is now ready to submit its recommendations to the Atlanta City Council and the Atlanta Board of Education; and

**WHEREAS**, any future action by the Council to revise the compensation of elected officials is not restricted or precluded by these recommendations, and it is the intention of the Council to take into consideration any recommendation made by the Elected Officials Compensation Commission and to comply with requirements for such legislative action established in Section 2-305 of the Charter; and

**WHEREAS**, any salary change shall not become effective until the date of commencement of the terms of officials elected at the next regular municipal election following the action to change.

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the report submitted by the City of Atlanta Elected Officials Compensation Commission on recommendations concerning compensation of certain City of Atlanta Elected Officials as contemplated by Section 2-703 of the Atlanta City Charter is hereby accepted and attached hereto as Exhibit A.
