

ORDINANCE AMENDING THE 2000 (COMMUNITY DEVELOPMENT FUND) BUDGET BY TRANSFERRING TO AND FROM APPROPRIATIONS IN THE AMOUNT \$316,468.67 TO FUND SIDEWALKS FOR THE UTOY CREEK SEWER SEPARATION PROJECT IN THE WEST END AREA; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta did choose sewer separation as a method of choice to deal with its wastewater in the Utoy Creek Basin; and

WHEREAS, this method of sewer separation required the acquisition and hundreds of rights-of-way in the West End Area which left an inordinate number of sidewalks in disrepair; and

WHEREAS, the City of Atlanta did not make provisions for these sidewalks to be repaired; and

WHEREAS, the City of Atlanta is currently reprogramming Community Development Block Grant Funds that are no longer needed for their original purpose; and

WHEREAS, the City of Atlanta and its citizens will benefit greatly from the use of these funds for sidewalk purposes in an area that is in dire need of sidewalks.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the Sixteenth Year CDBG Program be and is amended hereby as follows:

- a. In program element *Economic Development/Enhancement* by deleting in the project "West End/Lee Street Improvements" the amount "\$750,000.00" and inserting in lieu thereof the amount "\$704,417.23".
- b. In program element *Public Improvements* by adding the project "West End Sidewalks" and the amount "\$45,582.77".

Section 2: That the Twenty-First Year CDBG Program be and is amended hereby as follows:

- a. In program element *Economic Development/Enhancement* by deleting in the project "West End/Lee Street Improvements" the amount "\$433,315.00" and inserting in lieu thereof the amount "\$430,042.79".
- b. In program element *Homeless Facilities* by deleting in the project "House of Love and Hope" the amount "\$100,000.00" and inserting in lieu thereof the amount "\$64,134.66".
- c. In program element *Public Improvements* and by adding the project "West End Sidewalks" and the amount "\$39,276.90".



Section 3: That the Twenty-Second Year CDBG Program be and is amended hereby as follows:

- a. In program element *Homeless Facilities* by deleting in the project "House of Love and Hope" the amount "\$317,000.00" and inserting in lieu thereof the amount "\$99,849.00".
- b. In program element *Public Improvements* and by adding the project "West End Sidewalks" and the amount "\$217,151.00".

Section 4: That the Twenty-Third Year CDBG Program be and is amended hereby as follows:

- a. In program element *Public Improvements* by deleting the project "ComCare Housing Site Improvements" and the amount "\$14,458.00" and by adding the project "West End Sidewalks" and the amount "\$14,458.00".

Section 5: That the 2000 (Community Development Fund) Budget be and is amended hereby as follows:
