

FOR FC-6980-97, ANNUAL CONTRACT FOR SURVEYING & MAPPING SERVICES ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS IN AN AMOUNT NOT TO EXCEED ONE MILLION FIVE HUNDRED FOUR THOUSAND FOUR HUNDRED SEVENTY-EIGHT DOLLARS (\$1,504,478.00); AND TO ACCEPT THE NAME CHANGE OF W.L. JORDEN & COMPANY, INC. TO HDR/W.L. JORDEN, INC. TO BE REFERRED TO HEREIN THEREAFTER. ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND ACCOUNT AND CENTER NUMBER: 2J26 524001 M24I02239999.

**WHEREAS**, the City of Atlanta did enter into FC-6980-97, Annual Contract for Surveying and Mapping Services; and

**WHEREAS**, W. L. Jordan & Company, Inc., was recently acquired by HDR, Engineering Inc. (HDR) and appropriate documentation has been submitted indicating that the name W. L. Jordan & Company, Inc. (WLJ) has been changed to HDR/W.L. Jordan, Inc.; and

**WHEREAS**, the Department of Public Works does require Surveying and Mapping Services to meet some of the Consent Decree Projects for the development of GIS Decision and Information Management Framework to assist with decisions regarding CSO Remediation Alternatives and Sewer Capacity; and

**WHEREAS**, the Commissioner of the Department of Public Works and the Director of the Bureau of Purchasing and Real Estate have recommended W.L. Jordan Co., Inc., to provide Surveying and Mapping Services to comply with Consent Decree in an amount not to exceed One Million Five Hundred Four Thousand Four Hundred Seventy-eight Dollars (\$1,504,478.00); and.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor be and is hereby authorized to approve a Notice to Proceed with W. L. Jordan & Company, Inc. for FC-6980-97, Annual Contract for Surveying and Mapping Services in an amount not to exceed One Million Five Hundred Four Thousand Four Hundred Seventy-eight Dollars (\$1,504,478.00); and to accept the name change of W. L. Jordan & Company, Inc., (WLJ) to HDR/W.L. Jordan, Inc.; and


