AN ORDINANCE AMENDING THE 2000 (AIRPORT REVENUE BOND FUND) BUDGET BY TRANSFERRING TO AND FROM APPROPRIATIONS THE AMOUNT OF \$6,847,466.00 FOR THE PURPOSE OF FUNDING A REIMBURSABLE AGREEMENT WITH THE GEORGIA POWER COMPANY FOR THE REMOVAL AND RELOCATION OF POWER LINES AND A SUBSTATION NECESSITATED BY THE CONSTRUCTION OF THE FIFTH RUNWAY PROJECT AT HARTSFIELD ATLANTA INTERNATIONAL AIRPORT.

**WHEREAS**, the City of Atlanta, as owner and operator of the Hartsfield Atlanta International Airport, has undertaken a major expansion of the Airport to accommodate the increasing air traffic at the airport, including construction of a Fifth Runway; and

**WHEREAS**, the Fifth Runway construction project will require the removal and relocation of power lines, poles, a substation and related equipment, among other things, owned and operated by Georgia Power Company; and

**WHEREAS**, in order to accomplish the relocation, Georgia Power Company requires the reimbursement of costs associated therewith, including advance payment for acquisition of materials that require lead time and for preliminary engineering charges; and

**WHEREAS**, City is entering into an agreement with Georgia Power Company in order to provide for accomplishment of the work by Georgia Power Company and reimbursement of the cost thereof by the City, as hereinafter set forth; and

**WHEREAS**, it is now necessary to amend the 2000 Airport Revenue Bond Fund Budget to appropriate funds for said reimbursable agreement.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS** as follows:

**Section 1:** That the 2000 Airport Revenue Bond Fund be and hereby is amended as follows:
