RESOLUTION AMENDING THE CITY'S CONSOLIDATED PLAN TO CHANGE THE WORK PROGRAM OF THE MECHANICSVILLE/ PEOPLESTOWN/SUMMERHILL PROJECT TO INCLUDE A HOUSING REHAB COMPONENT FOR ADAIR PARK AND OAKLAND CITY; TO CHANGE THE WORK PROGRAM OF THE PITTSBURGH PARTNERSHIP FACILITY PROJECT TO INCLUDE A COMPONENT FOR HOUSING REHAB FOR PITTSBURGH; AUTHORIZING THE MAYOR TO ENTER INTO CONTRACTS FOR THE IMPLEMENTATION OF THE QLS MEADOWS AND CAMP BUILDING ACQUISITION PROJECTS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta approved funding for the CAMP Building Acquisition and QLS Meadows projects in the recent CDBG reprogramming; and

WHEREAS, these projects are ready for implementation based on the filing of environmental clearances with the U.S. Department of Housing and Urban Development and the release of funds; and

WHEREAS, the Mechanicsville/Peoplestown/Summerhill has been amended to add a housing rehab component for the Adair Park and Oakland City communities and the Pittsburgh Partnership Facility has been amended to add a housing rehab component for the Pittsburgh community; and

WHEREAS, these changes constitute amendments to the City's Consolidated Plan; and

WHEREAS, it is required to submit to the U.S. Department of Housing and Urban Development any changes to the City's Consolidated Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the Mayor be and is hereby authorized to submit to the U.S. Department of Housing and Urban Development an amendment to Atlanta's Twenty-Second Year CDBG Program to include changes to the Mechanicsville/Peoplestown/Summerhill to add a housing rehab component for Adair Park and Oakland City.

Section 2: BE IT FURTHER RESOLVED that the Mayor be and is hereby authorized to submit to the U.S. Department of Housing and Urban Development an amendment to Atlanta's Twenty-Third Year CDBG Program to include changes to the Pittsburgh Partnership Facility to add a housing rehab component for Pittsburgh.

Section 3: BE IT FURTHER RESOLVED that the Mayor or his designee be and is hereby authorized to enter into a contractual agreement with the CAMP Ministries for the implementation of CD-657, CAMP Building Acquisition in an amount not to exceed \$80,000.00 to be paid from and charged to accounts 1B01 529002 Y53P0937A56A-\$48,504.39 and 1B01 529002 Y53P0937A58A-\$31,495.61.

Section 4: BE IT FURTHER RESOLVED that the Mayor or his designee be and is hereby authorized to enter into a contractual agreement with the Quality Living Services for the implementation of CD-658, QLS Meadows in an amount not to exceed \$150,000.00 to be paid from and charged to accounts 1B01 529002 Y53P0938A58A-\$110,772.00 and 1B01 529002 Y53P0938A59A-\$39,228.00.

Section 5: BE IT FINALLY RESOLVED that the City Attorney be and is authorized hereby to prepare the appropriate contract agreements for execution by the Mayor, to be approved by the City Attorney as to form and that these contracts shall not become binding on the City and the City shall not incur no liability upon same until such time as these contracts have been signed by the Mayor and delivered to the contracting parties.
