A ORDINANCE

AN ORDINANCE AUTHORIZING THE MAYOR TO DECLARE AN EMERGENCY FOR THE PEDESTRIAN ACCESS ON A SEGMENT OF MARIETTA ROAD, NW EXTENDING FROM THE MARIETTA SENIOR HIGHRISE TO BOLTON ROAD, NW, DUE TO AUTOMOBILE AND TRACTOR TRAILER TRAFFIC.

WHERE AS, a segment of the right of way along Marietta Road, NW near the Marietta Senior Highrise is difficult for the citizens of the Highrise to move around that area; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:

Section 1. That the Mayor is hereby authorized to declare an emergency for the pedestrian access on a segment of the right-of-way along Marietta Road, NW near the Marietta Highrise to Bolton Road, NW.

Section 2. That the Mayor is authorized to direct the Department of Public Works to expedite the repair construction of the sidewalk along the appropriate segment of Marietta Road, NW.

Section 3. That the funds shall be expended to install and /or repair the sidewalk on the right-of-way along this section of the corridor.

Section 4. That the funds shall be expended from account # 000000000000000000.
