

**A SUBSTITUTE RESOLUTION
BY COUNCILMEMBER FELICIA A. MOORE
AS AMENDED BY FULL COUNCIL**

**A RESOLUTION TO ESTABLISH A TREE ORDINANCE TASK FORCE FOR
THE PURPOSE OF REVIEWING AND RECOMMENDING REVISIONS TO
THE TREE PROTECTION ORDINANCE FOR THE CITY OF ATLANTA;
AND FOR OTHER PURPOSES.**

WHEREAS, the Tree Protection Ordinance of the City of Atlanta, found at Chapter 158 of the Code of Ordinances of the City of Atlanta, Georgia (1995), herinafter “Atlanta City Code (1995)”, has been a work in progress, with need for further clarifications and revisions.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1. That an eighteen member Tree Ordinance Task Force is hereby established by the Community Development/Human Resources Committee for the purpose of reviewing and providing recommendations to revise and strengthen the Tree Ordinance. The members shall consist of the following:

- One member of the Tree Conservation Commission – Chair or Designee
- Four Atlanta Planning Advisory Board (APAB) representatives representing the north and south sections of the City
- One City Arborist
- Commissioner or designee from the City of Atlanta Department of Planning, Development and Neighborhood Conservation
- One representing the association of land developers
- One representing the association of home builders
- One representing the association of apartment builders
- Commissioner or designee from the City of Atlanta Department of Public Works
- Commissioner or designee from the City of Atlanta Parks, Recreation and Cultural Affairs
- Commissioner or designee from the City of Atlanta Law Department
- City of Atlanta Department of Planning, Development and Neighborhood Conservation, Bureau of Planning, Assistant Director of Development Review Division
- One representing the Urban Land Institute
- One representing Urban Planners
- One representing utilities companies
- One representing American Society of Landscape Architects



Section 2. That said task force shall provide recommendations for revisions to the Community Development/Human Resources Committee by the end of the fourth month after the passage of this legislation.

Section 3. That all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed.
