WHEREAS, the Atlanta Police Department currently leases and occupies space at 2581 Piedmont Road, for the Zone Two Precinct, and,

WHEREAS, the Atlanta Police Department wishes to extend the current lease through 2001,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to extend a lease agreement with Noro-Broadview Holding Co., B.V., for rental of 4,287 square feet of office space located at 2581 Piedmont Road, for the Atlanta Police Department Zone Two Precinct, beginning January 1, 2001, through December 31, 2001, in the amount not to exceed \$4,312.67 per month (\$51,752.04 per year), said payment to be charged to and paid from account number 1A01 525001 X42002.

BE IT FURTHER RESOLVED, that the City Attorney be and is hereby directed to prepare an appropriate contract for execution by the mayor to be approved by the City Attorney as to form.

BE IT FURTHER RESOLVED, that the City of Atlanta shall incur no liability until such contract has been executed by the Mayor and delivered to the contracting party.
