**A RESOLUTION SUPPORTING ATLANTA GAMES, INC  
IN THEIR BID TO HOST GAY GAMES VII FOR THE CITY  
OF ATLANTA IN THE YEAR 2006.**

**WHEREAS**, the Gay Games is an international event held every four years that features athletic and cultural events and that brings together people from around the world under the principles of inclusion and participation for all people; and

**WHEREAS**, it is estimated that over 18,000 athletes from around the world will compete in the 2006 games; and

**WHEREAS**, if Gay Games VII is awarded to the City of Atlanta, this event will draw an estimated crowd of one million people to the city; and

**WHEREAS**, it is estimated that the cultural program portion of the games will attract over three thousand performers and utilize over twenty performing arts venues throughout the City of Atlanta; and

**WHEREAS**, there would be an estimated economic impact of over \$350 million dollars over a ten day period for our city; and

**WHEREAS**, this event would demonstrate the City of Atlanta's continued commitment to our community values of non-discrimination and equal access for all citizens and visitors.

**NOW THEREFORE BE IT HEREBY RESOLVED BY THE COUNCIL OF  
THE CITY OF ATLANTA, GEORGIA**, to unanimously support the efforts of Atlanta Games, Inc. in securing the bid to host Gay Games VII in Atlanta for 2006.
