WHEREAS, the City of Atlanta is required by Code Section 78-31 to provide a uniform or uniform allowance each year in the amount of \$600.00 to the uniformed members of the Fire Department; and

WHEREAS, some uniformed members of the Fire Department have not received a uniform or a uniform allowance for 1999 and 2000; and

WHEREAS, certain non-uniformed personnel of the Fire Department have not received their allowance of \$600.00 for 1999 and 2000:

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA
hereby resolves as follows:

Section 1: That the Chief Financial Officer is hereby directed to provide uniform allowance to all sworn members of the Fire Department who have not received their 1999 and 2000 allowance.

Section 2: That the Chief Financial Officer is further directed to provide those non-uniformed personnel who perform fire duties but who do not wear uniforms their allowance for 1999 and 2000.

Section 3: All resolutions or parts of resolutions in conflict herewith are hereby repealed.
