**AN ORDINANCE AMENDING THE 2001 (1994 REFERENDUM G.O. BOND FUND) BUDGET BY TRANSFERRING APPROPRIATIONS IN THE AMOUNT OF \$814,973.89 FROM THE INTEREST RESERVE ACCOUNT TO AN APPROPRIATIONS ACCOUNT TO FUND THE SALARIES AND OPERATING CONTRACTUAL, FINANCIAL, ADMINISTRATIVE AND TECHNICAL SERVICES TO THE 1994 PUBLIC IMPROVEMENT PROGRAM; AND FOR OTHER PURPOSES.**

**WHEREAS**, Ordinances were adopted by Council on July 5, 1995, March 18, 1996, February 2, 1998 and approved by the Mayor on July 11, 1995, March 25, 1996 and February 9, 1998 amending Article "C" Classification Plan, Sections 5-2062 and 114-477 of the Code of Ordinances, City of Atlanta, Georgia so as to create, abolish and amend the titles of certain positions in line with the 2000 Budget; and

**WHEREAS**, the aforementioned ordinances created and/or amended within the Department of Public Works for administrative and technical duties related to the 1994 Referendum Infrastructure Program; and

**WHEREAS**, sufficient funds need to be appropriated to the 1994 G.O. Bond Fund to fund administrative expenses for these positions.

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, as follows:

**SECTION 1:** That the 2001 (1994 Referendum General Obligation Bond Fund) Budget be and is hereby amended as follows:


