Dear Municipal Clerk,

This letter serves as supplemental documentation to the claim form mailed by your office for me to complete and return to you. As the claim form indicates, I have suffered damages in the amount sum of \$563.74. The incident occurred late night on Monday, July 10, 2000. While I was driving westbound, towards downtown, on E. Ponce De Leon Avenue, I drove over a manhole that is several inches below the paved street. This manhole is located in the left lane, just east of City Hall East, between the Kroger shopping center and City Hall East. The cross streets are Glen Iris Drive and Ponce De Leon Place. Driving over this 'hole' caused my front passenger wheel to bend and crack. I attempted to have the wheel repaired (see attached invoice for \$25.00 from Wheel Wizard), however since the wheel is cracked it cannot be repaired, and has to be replaced.

My vehicle is a 1998 Volvo C70. I tried to get another estimate from several tire stores, however since my car uses 18-inch BBS wheels made for Volvo, I was told I would have to get this part from the dealer. I contacted Chris Volvo, and Dyer & Dyer Volvo for the cost of a replacement part plus labor. The part plus labor cost is over \$500.00. The less expensive of the two estimates is \$538.74. I am paying these damages, not my insurance company. Please feel free to contact me with any questions or comments.


