AN ORDINANCE TO RENAME FOUNDRY STREET & LUCKIE STREET (FROM CENTENNIAL OLYMPIC PARK TO THURMOND STREET) TO "PARK AVENUE WEST."

WHEREAS, Foundry Street and a portion of Luckie Street are the geographical borders of the western edge of Centennial Olympic Park, and have experienced a high amount of positive urban development that has contributed to extending the success of the park into the surrounding community; and

WHEREAS, the creation of Centennial Olympic Park has disconnected Luckie Street, and created a bend rather than an intersection where Luckie Street and Foundry Street meet, and should therefore be joined under one name to eliminate any unnecessary confusion for visitors to the area; and

WHEREAS, the name "Park Avenue West" symbolically connects this road to Centennial Olympic Park, the centerpiece of the new Downtown residential area;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA THAT:

Section 1: That Luckie Street (from Centennial Olympic Park to Thurmond Street) and Foundry Street be renamed to "Park Avenue West."

Section 2: The City of Atlanta's Bureau of Traffic and Transportation install the necessary signage and that all City of Atlanta maps so note this designation.

Section 3: All ordinances in conflict herewith are hereby rescinded.





Dear Councilmember Starnes,

We are requesting your assistance in renaming Foundry Street and a portion of Luckie Street to "Park Avenue West". It is our opinion that this new name will help to establish an association between Centennial Olympic Park and the adjoining community, creating a unique sense of place for this rapidly growing urban neighborhood.

Luckie Street has been divided by the park, and the portion to the south is no longer known as Luckie Street. The northern part of Old Luckie Street currently begins at Centennial Olympic park where it intersects with Foundry Street. This is in actuality more of a bend of one road than an intersection of two based on the fact that both roads dead-end into the park. For this reason, we propose joining these two streets under one easily identifiable name, "Park Avenue West." Luckie Street leads to a disjointed multi-street intersection of Thurmond and Baker Streets to the north. This creates a logical beginning to Luckie Street north of Thurmond at this intersection. A map of the area is attached to more clearly illustrate this point.

The name "Park Avenue West" has been proposed for this "new" road for a number of reasons. We feel that by incorporating the word "park" into the street name, we are symbolically connecting Centennial Olympic Park with the adjoining neighborhood. The name "Park Avenue" is a direct reference to New York City's Park Avenue on the edge of Central Park. This creates a unique parallel between two similar urban park destinations in two major U.S. cities. "Park Avenue West" was created by using a consensus building process, and has been approved by the only other affected property owner, Centennial Olympic Park. A letter from Mark Banta, General Manager of Centennial Olympic Park, is included which agrees with the recommendation of "Park Avenue West" as the most desirable name for this "new" street.

Enclosed, please find general background information for your review including parcel and location maps and property owner's names and addresses.
