AN ORDINANCE TO AMEND ORDINANCE
U-76-31, ADOPTED BY CITY COUNCIL
JANUARY 3, 1977 AND APPROVED BY THE
MAYOR JANUARY 11, 1977, PROPERTY LOCATED
AT **352 UNIVERSITY AVENUE, S.W.**, TO APPROVE
A TRANSFER OF OWNERSHIP OF A SPECIAL USE
PERMIT FOR A TRUCK TERMINAL FACILITY AND
FOR OTHER PURPOSES.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1. That the transfer (i.e. change of grantee) of Special Use Permit U-76-31 for a Truck Terminal Facility located at **352 University Avenue, S.W.**, from Brown Transport Corporation to United Parcel Service, Inc. is hereby approved under the provisions of the 1982 City of Atlanta Zoning Ordinance, Section 16-25.002(2)(a).

SECTION 2. That the currently governing conditional site plan entitled "Plot Plan, Brown Transport Terminal" 352 University Avenue, Atlanta, dated August 8, 1976, revised December 13, 1976 received and dated December 14, 1976 by the Bureau of Planning, applicable to Special Use Permit U-76-31, is hereby deleted in its entirety and a new site plan entitled "Proposed Site, University Avenue, United Parcel Service" undated and marked received by the Bureau of Planning March 12, 2001 is hereby adopted in lieu thereof under the provisions of Section 16-25.003(3) of the 1982 City of Atlanta Zoning Ordinance.

SECTION 3. That all ordinances or parts of ordinances in conflict with the terms of this ordinance are hereby repealed.


