AN ORDINANCE TO AMEND THE CITY OF ATLANTA, CODE OF ORDINANCES, CHAPTER 106, ARTICLE III, SECTION 106-88 SO AS TO ALLOW PERSONS TO MOVE HOUSEHOLD GOODS ON SUNDAY; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, Section 106-88 prohibits persons from moving household goods on Sunday or at night; and

WHEREAS, the Council recognizes that many citizens are not off during the week and sometimes may only be able to move on Sunday; and

WHEREAS, the Council recognizes that traffic is less congested on Sunday and movers may have less of an impact on traffic on Sunday than other days of the week when accidents and heavy traffic congest city streets and roadways.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1.

That Chapter 106, Article III, Section 106-88 of the Code of Ordinances which currently states:

Sec. 106-88. Moving household goods at night or on Sunday.

It shall be unlawful for any person to move or transport household goods and furnishings from one place of residence to another between the hours of sunset and sunrise or on Sunday without first having obtained a permit to do so from the police chief. All applications for permits shall be filed more than 24 hours prior to the time of actual moving.

(Code 1977, § 17-3014)

be amended to delete the words "or on Sunday" from the caption and the text of Section 106-88, so that as amended the legislation will read:

Sec. 106-88. Moving household goods at night.

It shall be unlawful for any person to move or transport household goods and furnishings from one place of residence to another between the hours of sunset and sunrise without first having obtained a permit to do so from the police chief. All applications for permits shall be filed more than 24 hours prior to the time of actual moving.



SECTION 2.

That all ordinances or parts of ordinances in conflict herewith are hereby repealed.
