A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF ATLANTA TO IMPLEMENT BY EXECUTIVE ORDER THE INTENT OF AN ORDINANCE TO ESTABLISH A "VOLUNTARY SHARED LEAVE PROGRAM"; AND FOR OTHER PURPOSES.

WHEREAS, there are employees or immediate family members of employees who are confronted with severe illnesses that may result in an employee's use of all available leave and loss of substantial income; and

WHEREAS, the city desires to enhance its current leave policy by establishing a voluntary leave donor program that provides for the transfer of leave between employees; and

WHEREAS, a leave donation program can strengthen team spirit, improve morale and demonstrate a commitment to the workforce; and

WHEREAS, an ordinance will be introduced at the City Council Meeting on April 2, 2001 to establish a "Voluntary Shared Leave Program".

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the Mayor is hereby authorized to implement by Executive Order the intent of an ordinance to be introduced at the City Council Meeting on April 2, 2001 to establish a "Voluntary Shared Leave Program".

Section 2: That all resolutions or parts of resolutions in conflict herewith are hereby rescinded.
