**A RESOLUTION TO EXPRESS THE INTENT OF THE ATLANTA CITY COUNCIL TO AMEND ITS DISTRICT BOUNDARIES AS A RESULT OF THE 2000 DECENNIAL CENSUS AS REQUIRED BY ATLANTA CITY CHARTER SECTION 5-202, "REAPPORTIONMENT OF COUNCIL DISTRICTS." AND RESOLUTION TO RESCIND RESOLUTION 01-R-0646.**

**WHEREAS**, Charter Amendment Ordinance 01-O-0589 has been introduced to amend the Council District boundaries as a result of the 2000 Decennial Census as required by Section 5-202 "Reapportionment of Council Districts" of the Charter of the City of Atlanta;

**WHEREAS**, ten alternative district maps (Alternative 1, 2, 3, 4, 5, 6, 7, 8, 9 and 11) have been proposed and considered by City Council;

**WHEREAS**, these maps have been commented upon by members of the public at public hearings scheduled for that purpose;

**WHEREAS**, it is necessary for the City Council to select one of these redistricting maps of new council district boundaries to attach to Charter Amendment Ordinance 01-O-0589 and to adopt as Council Districts pursuant to Section 5-202 of the City Charter;

**WHEREAS**, the identification of a single map of new council district boundaries will allow for boundary descriptions of each of the twelve districts and the appropriate publisher's affidavit to be prepared for attachment to Charter Amendment Ordinance 01-O-0589;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that it is the intent of the Atlanta City Council that the Redistricting Map identified as Alternative II be attached to Charter Amendment Ordinance 01-O-0589 and that the Council Districts represented thereon be adopted as a part of that ordinance in accordance with Section 5-202 of the Atlanta City Charter.

**BE IT FURTHER RESOLVED**, that Resolution 01-R-0646, adopted as amended by Council on April 19, 2001, and approved as per operation by law on April 28, 2001, is hereby repealed.
