



**AMENDING THE DEPARTMENT OF CORRECTIONS, 2001 GENERAL FUND BUDGET, CITY OF ATLANTA, GEORGIA SO AS TO APPROPRIATE SUFFICIENT FUNDS TO ENSURE ADEQUATE PRISONER STAFFING AT GRADY HOSPITAL IN COMPLIANCE WITH FEDERAL ACCREDITATION REQUIREMENTS EFFECTIVE JUNE 1, 2001; AND FOR OTHER PURPOSES.**

WHEREAS, Grady Health System (GHS) must comply with the accreditation standards of the Joint Commission on Accreditation of Healthcare Organizations (JCAHO) to maintain eligibility for federal funding; and

WHEREAS, GHS has recently informed local law enforcement agency users that the JCAHO standards require continuous one-to-one prisoner supervision in the hospital; and

WHEREAS, the Department of Corrections is not currently authorized to comply with the new staffing standard; and

WHEREAS, the required additional staffing must be provided not later than June 1, 2001; and

WHEREAS, the Department of Corrections proposes to attain compliance with the new staffing standard by utilizing the services of private security guards and city corrections personnel in an overtime capacity.

**NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:**

**Section 1:** That the 2001 General Fund Budget, Department of Corrections is amended hereby as follows:
