**AN ORDINANCE TO AMEND ARTICLE "V",  
CLASSIFICATION PLAN, SECTION 114-477, OF  
THE CODE OF ORDINANCES, CITY OF  
ATLANTA, GEORGIA, SO AS TO TRANSFER  
AND ABOLISH CERTAIN GRANT FUNDED  
POLICE OFFICER POSITIONS IN THE  
DEPARTMENT OF POLICE AND FOR OTHER  
PURPOSES**

**WHEREAS,** The City of Atlanta received funding from the U.S. Department of Justice in 1997 to fund fifty Police Officer positions under the Universal Hiring Grant with the condition that these grant funded positions after the expiration of the grant would be absorbed with local funds; and

**WHEREAS,** The funding for six of these positions has expired and should therefore be abolished; and

**WHEREAS,** The funding for the remaining positions continue to exist and the Universal Hiring Grant which funded these positions is scheduled to expire on May 31, 2001 and the City is required by grantor terms and conditions to retain the grant funded positions for at least one budget cycle; and

**WHEREAS,** The 2001 General Fund Budget included funding for the retention of these positions for the period from June 1, 2001 to December 31, 2001.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:**

**SECTION 1 – POSITION ABOLISHMENTS:** That the following grant funded positions be and the same are hereby abolished in the indicated Department and Bureau/Office:
