AN ORDINANCE AUTHORIZING THE CHIEF FINANCIAL OFFICER TO REFUND A TOTAL OF \$12,916.80 TO HILL RUFUS E & GRAY LEO FOR OVERPAYMENT OF SANITARY SERVICES CHARGES FOR THE YEAR(S) 1996, 1997 AND 1998 FOR PROPERTY AT 1960 ALISON COURT, SW PARCEL IDENTIFICATION NUMBER 14-0167-0004-029-5

WHEREAS, the City of Atlanta Department of Public Works, Solid Waste and Transportation Services is authorized to provide solid waste collection and disposal services to all residential and multi-family units with the City limits; and

WHEREAS, the amount of Sanitary Service Charge for the year(s) 1996, 1997 and 1998, Hill Rufus E. & Gray Leo, paid the cost for industrial container, plus street frontage for garbage collection and street maintenance: 1996: \$139.61 per each dwelling unit and \$124.24 per each 100 linear feet or the fraction thereof of paved street frontage; 1997: \$140.01 per each dwelling unit, plus \$124.65 per each 100 linear feet or the fraction thereof of paved street frontage and 1998 \$166.70 per each dwelling unit, plus \$148.33 per each 100 linear feet or the fraction thereof of paved street frontage; and

WHEREAS, for the year(s) 1996, 1997 and 1998, Hill Rufus E. & Gray Leo, established private garbage collection services for property at 1960 Alison Court, SW parcel identification number 14-0167-0004-029-5 effective August 31, 1995; and

WHEREAS, Hill Rufus E. & Gray Leo, request a refund for overpayment of 1996, 1997 and 1998 Sanitary Services Charges for property at 1960 Alison Court, Drive parcel identification number 14-0167-0004-029-5; and

WHEREAS, the City of Atlanta, Department of Public Works, did not provide garbage collection services to property at 1960 Alison Court Drive, SW parcel identification number 14-0167-0004-029-5 for the years 1996, 1997 and 1998, as confirmed by the Department of Public Works, Solid Waste and Transportation Services collection division April 6, 2001; and

WHEREAS, property at 1960 Alison Court, SW is eligible to be charged according to the Ordinance amended April 28, 1990 for apartment, condominiums and town homes property using private garbage collection and refund for overpayment of Sanitary Service Charges for 1996 \$5,079.88, 1997 \$5,105.00 and 1998 \$6,075.64; and

WHEREAS, the total Sanitary Services Charges fee amount for the years 1996 and 1997 were therefore, paid and satisfied under Atlanta property tax bill (See attached Copy of Atlanta property tax bill for 1996 and 1997; and accordingly 1998 Sanitary Services Charge amount \$9,113.39, was satisfied and paid to Capital Investment Inc.; and

WHEREAS, the total Sanitary Services Charges in the amount of \$9,113.39, was sold by Fulton County property tax division, to third party known as Capital Investment Inc., and property owner(s) Hill Rufus E. & Gray Leo paid a total of \$9,113.39, to Capital Investment Inc., for 1998 Sanitary Services Charges on June 1998 for property at 1960 Alison Court, SW parcel identification number 14-0167-0004-029-5 (see attached copy of payment; and

WHEREAS, it is desirable for the City of Atlanta to be equitable on all Sanitary Services Charges; and

THEREFORE, BE ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA AS FOLLOWS:



Section 1: The Chief Financial Officer is hereby directed to issue a refund to Hill Rufus E. & Gray Leo in the amount of \$12,916.80 which represents the amount of overpayment.

Section 2: A miscellaneous requisition be prepared by the Department of Public Works, Solid Waste and Transportation Services using Fund Account Center 1A01 529010 T31001.

Section 3: All Ordinances and parts of Ordinance in conflict herewith be the same hereby repealed.
