AN ORDINANCE TO AMEND ORDINANCE 01-O-0605 WHICH PROVIDED FOR THE CITY OF ATLANTA'S SOLID WASTE MANAGEMENT AUTHORITY (SWMA) TO LEASE LANDFILL SPACE FROM OTHER LANDFILL OWNERS; AND FOR OTHER PURPOSES.

WHEREAS, the city of Atlanta did create the Solid Waste Management Authority (SWMA) for the purpose of assisting with the financing of closing several of its landfills; and

WHEREAS, the city of Atlanta by way of Ordinances 01-O-0345 and 01-O-0605 expand the purpose of the Solid Waste Management Authority (SWMA) by allowing it to lease landfill space from other landfill owners should the need arise; and

WHEREAS, the City Council shall have the authority to issue permits for solid waste facilities within their boundaries.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Ordinance 01-O-0605 amended by adding a new Section 3 which shall read as follows:

SECTION 3: The authority given in Section 1 of this ordinance shall expire on December 31, 2001.

SECTION 4: The authority given in Section 1 of this ordinance shall not provide for the authority to permit or site any solid waste transfer station or any accessory use for the lease.

SECTION 2: That the old Section 3 shall be renumbered to a new Section 5.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.

AN ORDINANCE TO AUTHORIZE AN AMENDMENT TO THAT CERTAIN CONTRACT DATED DECEMBER 1, 1996 BY AND BETWEEN THE CITY OF ATLANTA AND THE SOLID WASTE MANAGEMENT AUTHORITY OF THE CITY OF ATLANTA (SWMA) REGARDING THE FINANCING AND CLOSURE OF CITY-OWNED LANDFILLS WHICH AMENDMENT SHALL PROVIDE FOR SWMA TO LEASE LANDFILL SPACE FROM OTHER LANDFILL OWNERS ON BEHALF OF THE CITY OF ATLANTA AND FOR OTHER PURPOSES.

WHEREAS, the Solid Waste Management Authority (SWMA) was activated by the City of Atlanta on September 20, 1993 pursuant to Ordinance #93-0-1484; and

WHEREAS, SWMA was created for the purpose of financing the closure of landfills owned by the City of Atlanta; and

WHEREAS, pursuant to Ordinance #01-0-0354, adopted March 19, 2001 and approved March 27, 2001, the City seeks to expand the role of SWMA in assisting the City with solid waste management issues; and

WHEREAS, the leasing of landfill space from other landfill owners by SWMA on behalf of the City would greatly assist the City in the management of its solid waste.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS,
as follows:



SECTION 1. The mayor is hereby authorized to execute an amendment to that certain contract dated December 1, 1996 by and between the City of Atlanta and the Solid Waste Management Authority of the City of Atlanta (SWMA) regarding the financing and closure of City-owned landfills, which amendment shall provide for SWMA to lease landfill space from other landfill owners on behalf of the City of Atlanta **subject to budget appropriations being identified.**

SECTION 2: That the amendment authorized by Section One of this ordinance shall not apply to the use, lease, purchase or other temporary or permanent acquisition of landfill space in Fulton, DeKalb or Clayton Counties.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

ORDINANCE

AN ORDINANCE TO AMEND SECTION 2 OF ORDINANCE NO. 94-O-0445 SO AS TO PROVIDE THAT ANY CONTRACT BETWEEN THE CITY OF ATLANTA AND THE CITY OF ATLANTA SOLID WASTE MANAGEMENT AUTHORITY BE FOR ANY PURPOSE FOR WHICH THE AUTHORITY IS AUTHORIZED TO UNDERTAKE PURSUANT TO O.C.G.A. § 12-8-56; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, on September 20, 1993 the Council of the City of Atlanta passed legislation to activate the City of Atlanta Solid Waste Management Authority pursuant to the Regional Solid Waste Management Authorities Act (Code 1981, § 12-8-50), enacted by Ga. (1990, p. 412, § 1.); and

WHEREAS, upon recommendation by the Authority that Section 9 of Ordinance No. 93-O-1484 be amended to allow for the financing and administration of the closure of any city owned or operated landfill in addition to the closure of the Gun Club Road Landfill, the Council adopted and the Mayor approved Ordinance No. 94-O-0445; and

WHEREAS, the Authority recommends that Section 2 of Ordinance No. 94-O-0445 be amended to allow for the financing and administration of any other purpose authorized pursuant to O.C.G.A. § 12-8-56:

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Section 2 of Ordinance No. 94-O-0445 which reads:

Any contract which the City of Atlanta may enter into with the City Atlanta Solid Waste Management Authority shall be for the sole purpose financing and administration of the closure of any city owned or operated landfill.

be deleted in its entirety and the following shall be inserted in lieu thereof:

Any contract which the City of Atlanta may enter into with the City of Atlanta Solid Waste Management Authority shall be for the purposes of financing and administration of the closure of any city owned and operated landfill or for any other purpose for which the authority is authorized to undertake pursuant to O.C.G.A. § 12-8-56.

SECTION 2: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
