AN ORDINANCE TO AMEND CHAPTER 114, ARTICLE VI OF THE CODE OF ORDINANCES BY CREATING A NEW SECTION 114-505 TO PROVIDE FOR THE POLICY OF "MEET AND CONFER" BETWEEN REPRESENTATIVES OF EMPLOYEES AND EMPLOYEE ORGANIZATIONS MAYOR AND THE DIRECTOR OF THE BUREAU OF LABOR RELATIONS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta recognizes that employees who share a community of interest can enjoy representation by employee organizations; and

WHEREAS, such employee organizations may seek to discuss hours of work, wages and other terms and conditions of employment with City officials; and

WHEREAS, the Atlanta City Council wishes to enhance the level of communication between employee organizations and City officials;

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS AS FOLLOWS:

SECTION ONE: That Chapter 114, Article VI of the Code of Ordinances of the City of Atlanta be amended by creating a new Section 114-505 which shall provide as follows:

Section 114-505 Meet and Confer Sessions.

- (a) The Mayor, and the Director of the Bureau of Labor Relations as so designated by the Mayor, shall meet and confer annually with any interested employee organization group recognized for Deduction of Dues under Section 114-28 of this Code, for the purpose of discussing wages, rates of pay, working conditions, and other terms and conditions of employment.
- (b) Any consensus reached between the Mayor and employee labor organizations may be embodied in a written Memorandum of Understanding that shall last no more than one year, subject to approval by Resolution of the City Council.

SECTION TWO: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
