A SUBSTITUTE ORDINANCE RENAMING WEST MANOR RECREATION CENTER AT 3240 WEST MANOR CIRCLE IN SOUTHWEST ATLANTA BE RENAMED THE ANTHONY FLANAGAN MEMORIAL RECREATION CENTER AND TO WAIVE SECTION 2.2 OF THE CODE OF ORDINANCES TO ALLOW FOR SAID NAME CHANGE; AND FOR OTHER PURPOSES.

WHEREAS, Anthony “Flan-the-Man” Flanagan, a native Atlanta and the first black quarterback at the University of Georgia, was one of Atlanta’s most celebrated scholar-athletes; and,

WHEREAS, Anthony Flanagan was a multi-talented, “All-American” sport champion from Southwest High School, leading his team to two state championships in basketball, one state championship in football, and winning other tournaments in golf, tennis and swimming; and,

WHEREAS, Anthony Flanagan’s extraordinary athletic abilities took him to professional sport franchises across the nation such as the San Francisco Forty-Niners, the Boston Breakers and the Hawaii Volcanoes; and,


WHEREAS, Anthony Flanagan was a role model, mentor and hero to youth off the field through his youth programs and coaching career with the City of Atlanta Parks and Recreation Department at the John F. Kennedy Recreation Center; and,

WHEREAS, Anthony Flanagan’s personal dedication to helping young people excel in life and in sports inspired and positively influenced hundreds of youth in Atlanta; and,

WHEREAS, The Anthony Flanagan Scholarship Fund was established to help disadvantaged youth attend college; and,

WHEREAS, Anthony Flanagan departed his earthly life on January 12, 2001, the City of Atlanta salutes his dedication to mentoring youth in his Southwest Atlanta community.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that:



Section 1: West Manor Recreation Center at 3240 West Manor Circle in Southwest Atlanta be renamed the Anthony Flanagan Memorial Recreation Center.

Section 2: Section 2.2 of the City of Atlanta Code of Ordinances be waived to allow for said name change.

Section 3: The changes are effective upon the Mayor's signature of approval.

Section 4: The appropriate City agencies, including but not limited to the Department of Parks and Recreation, Department of Public Works, Bureau of Planning and the Clerk of Council, are hereby directed to take such steps as necessary to have the name change duly reflected on City of Atlanta maps, and other official documents and markers.

Section 5: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
