AN ORDINANCE BY  
THE PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE 01-0-0992

AN ORDINANCE TO AMEND CHAPTER 162, ENTITLED VEHICLES FOR HIRE, ARTICLE II, SECTION 162-43, SO AS TO PROVIDE A PENALTY FOR VIOLATIONS OF CHAPTER 162, ARTICLE II, SECTION 162-61(a), AS IT RELATES TO THE AGE LIMITS OF TAXICABS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta recently enacted an ordinance to provide age limitations for taxicabs operating within its jurisdiction.

WHEREAS, the City of Atlanta now wishes to provide a penalty for violations of such ordinance, in order to provide for the health, safety, and general welfare of its citizens and visitors.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

**SECTION 1.**

That Section 162-43 of the Code of Ordinances be amended to add the following language above provision entitled "Corrections and Related Matters":

APPEARANCE REQUIRED BEFORE HEARING PANEL

*Offense:*

Section 162-61(a), exceeding age limitations for taxicabs.

*Fine:*

CPNC holder:

First offense, \$250 fine, verbal reprimand.

Second offense, \$250 fine, 30 suspension of CPNC.

Third offense, \$500 fine, 90 day suspension of CPNC up to revocation of CPNC.

Taxicab driver:

First offense, \$250 fine, car towed, verbal reprimand.

Second offense, \$250 fine, 30 suspension of permit.

Third offense, \$500 fine, 90 day suspension of permit up to revocation of permit.



**SECTION 2.**

That all ordinances or parts thereof which conflict with this ordinance are hereby repealed.
