**AN ORDINANCE TO TRANSFER A TOTAL OF \$20,000, (\$10,000 FROM
DISTRICT 8 AND \$10,000 FROM DISTRICT 7) COUNCILMEMBERS'
EXPENSE ACCOUNTS TO THE DEPARTMENT OF PLANNING,
DEVELOPMENT, AND NEIGHBORHOOD CONSERVATION TO
TRANSFER TO BATMA (BUCKHEAD AREA TRANSPORTATION
MANAGEMENT ASSOCIATION) FOR PARTIAL MATCHING FUNDS FOR
THE LIVABLE CENTERS INITIATIVE GRANT.**

WHEREAS, Buckhead Action Committee (BAC), a committee of the Buckhead Business Association has applied through Buckhead Area Transportation Management Association (BATMA) for a Livable Centers Initiative grant through Atlanta Regional Commission; and

WHEREAS, BAC has been awarded this Livable Centers Initiative grant in the amount of \$70,000; and

WHEREAS, the visioning and planning process envisioned for Buckhead has been estimated to cost \$300,000; and

WHEREAS, the BAC is applying for other matching funds from foundations and private contributions; and

WHEREAS, other organizations in Buckhead have donated matching funds to this grant; and

WHEREAS, the city elected representatives of Buckhead from Atlanta City Council desire to insure that Atlanta City government also participate in this endeavor.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that \$10,000 shall be transferred from Council District 8 councilmember expense account and \$10,000 shall be transferred from Council District 7 councilmember expense account, for a total of \$20,000, to the Department of Planning, Development and Neighborhood Conservation for use in matching a planning effort in Buckhead.
