AN ORDINANCE AMENDING PART 13, CHAPTER 2, SECTION 150 OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA, SO AS TO ESTABLISH A RESIDENTIAL PERMIT PROGRAM IN A SECTION OF INMAN PARK ON AUSTIN AVENUE, NE BETWEEN ELIZABETH STREET, NE AND SINCLAIR AVENUE, NE; ELIZABETH STREET, NE, BETWEEN AUSTIN AVENUE, NE AND WAVERLY WAY, NE; SINCLAIR AVENUE, NE BETWEEN AUSTIN AVENUE, NE AND SEMINOLE AVENUE; SEMINOLE AVE., NE BETWEEN SINCLAIR AVE., NE AND CLEBURNE AVE., NE. CLEBURNE AVE, NE.; AND FOR OTHER PURPOSES.

WHEREAS, a section of the Inman Park area within the City of Atlanta has an insufficient number of on-street parking spaces available to accommodate the parking needs of the residents living in this area of Inman Park; and

WHEREAS, it is in the best interests of the City to reduce hazardous traffic conditions resulting from the use of this residential area for the parking of vehicles by persons using nearby commercial areas, office areas, parks, and other such facilities; and,

WHEREAS, it is in the best interest of the City to protect the residents of this area from unreasonable burdens in gaining access to their residences; and,

WHEREAS, it is in the best interests of the City to preserve the safety of children and other pedestrians, and the peace, good order, comfort, convenience, and welfare of the inhabitants of this area and of the City of Atlanta.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that residential streets within an area bounded by Austin Avenue, NE between Elizabeth Street, NE and Sinclair Avenue, NE; Elizabeth Street, NE between Austin Avenue, NE and Waverly Way, NE and; Sinclair Avenue, NE, between Austin Avenue, NE and Seminole Avenue, NE; Seminole Ave., NE between Sinclair Ave., NE AND Cleburne Ave., NE. Cleburne Ave, NE. shall be limited to residential parking by permit only and shall be so posted with signage.
