AN ORDINANCE TO INSTALL TWO "NO LEFT TURN" SIGNS; ONE AT COLLIER ROAD AND DELLWOOD DRIVE AND THE OTHER AT COLLIER ROAD AND REDLANDS DRIVE.

WHEREAS, there are many families with small children and pets that live along Redlands Drive and Dellwood Drive and within the surrounding neighborhood; and

WHEREAS, both Redlands Drive and Dellwood Drive intersect with Colonial Homes Drive, which is the location of a large multi-family apartment building and is the street constantly used by commuters to bypass the Piedmont Hospital intersection and to cut through to Peachtree Street.

WHEREAS, the residents from the single-family homes who live along Redlands, Dellwood and the other streets within this residential neighborhood cannot safely walk with their children or pets because of the safety hazard caused by cut through and speeding traffic.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1: That "no left turns from 7:00 am to 9:00 am and 4:00 pm to 6:00 pm" be installed on Collier Road at Redlands Drive and on Collier Road at Dellwood Drive, with signs facing eastbound traffic.

SECTION 2: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
