BY COUNCILMEMBER CATHY WOOLARD AND LEE MORRIS

A RESOLUTION SUPPORTING CONGRESSMAN JOHN LEWIS IN HIS EFFORTS TO ENSURE THE CITIZENS OF THE CITY OF ATLANTA RECEIVE A FAIR SHARE OF FEDERAL TRANSPORTATION DOLLARS.

WHEREAS, Congressman John Lewis has filed an administrative complaint to the U.S. Department of Transportation requesting an investigation of the distribution of federal transportation dollars among the state Congressional districts; and

WHEREAS, Congressman Lewis believes that the current allocation violates Title VI of the federal Civil Rights Act because the allocation formula does not provide adequate funding to meet the transportation needs of the residents of the Fifth Congressional District; and

WHEREAS, the Fifth District's share of federal transportation funding should be allocated for traffic calming, expanded and convenient Inner-city mass transit, sidewalks, bike lanes and sound barriers for the residents of the City of Atlanta; and

WHEREAS, focusing federal transportation funding on these projects will help to ensure that residents have adequate access to available resources and will promote smart growth within our city.

NOW THEREFORE BE IT HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, to unanimously support the efforts of Congressman John Lewis in his efforts to ensure the citizens of the City of Atlanta receive a fair share of federal transportation dollars.
