**AN ORDINANCE TO TRANSFER FUNDS BUDGETED IN THE
GENERAL FUND AND APPROPRIATED IN THE NON
DEPARTMENTAL, RESERVE ACCOUNT TO THE ATLANTA
POLICE DEPARTMENT GENERAL FUND, MOTORIZED
EQUIPMENT ACCOUNT IN THE OFFICE OF THE DEPUTY
CHIEF, ADMINISTRATIVE SERVICES DIVISION COST
CENTER FOR THE PURCHASE OF A LIGHT TURBINE
HELICOPTER.**

WHEREAS, the Atlanta Police Department is currently in possession of three helicopters referred to as the Bell Jetranger B III Model 206 tail number N5TC, Hughes Helicopter OH-6 tail Number N13PD and Hughes Helicopter OH-6 tail Number N72PD, and

WHEREAS, the Bell Jetranger B III Model 206 tail number N5TC was purchased by the Atlanta Police Department, and Hughes Helicopter OH-6 tail Number N13PD manufactured in 1967 were utilized by the US Army until they were donated to the Atlanta Police Department in 1996 to assist with the Olympic Games, and

WHEREAS, the Bell Jetranger B III Model 206 tail number N5TC and Hughes Helicopter OH-6 tail Number N13PD have out lived their useful lives of twenty-five years respectively (1967to 2001), and

WHEREAS, the Atlanta Police Department in cognizance of the life expectancy of the Bell Jetranger B III Model 206 tail number N5TC and Hughes Helicopter OH-6 tail Number N13PD has requested the amount of Two Million, Eight Hundred Thousand Dollars (2,800,000) during BY 2000 to replace the first two (2) helicopters described herein, and

WHEREAS, FY 2001 Adopted Budget approved One Million, Three Hundred and Sixty, Four Hundred Twenty-five Dollars (\$1,360,425) to purchase and replace one of the helicopters indicated above.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:
