A RESOLUTION TO AUTHORIZE THE MAYOR TO ACCEPT FUNDING FROM THE FEDERAL RESERVE BANK OF ATLANTA TO BE DESIGNATED FOR USE BY THE POLICE ATHLETIC LEAGUE OF THE ATLANTA POLICE DEPARTMENT, AND FOR OTHER PURPOSES

WHEREAS, the Police Athletic League, (PAL), is an organization incorporated in 1980 within the Atlanta Police Department, and

WHEREAS, the purpose of PAL is to foster, mentor and encourage in the youths in the City of Atlanta, a spirit of loyalty, values and faith in American traditions and institutions, and

WHEREAS, the PAL generates revenue through fundraising, donations and contributions from members of the general public and the greater Atlanta area such as the National Football League (NFL), and the Atlanta Falcons, and

WHEREAS, funds generated and raised by PAL have been used to decrease the violent victimization of youths via its athletic activities, improve academic performance of all its members through increased visitation of its "Homework Assistance Program", "Computer Center", and the provision of internet accessibility, and

WHEREAS, PAL has expressed a need to obtain additional funds for operational purposes and other youth athletic programs, and

WHEREAS, the Atlanta Police Department wishes to provide funds to PAL by committing revenue reimbursed by the Federal Reserve Bank of Atlanta for services rendered in the amount of Eighteen Thousand, Two Hundred Thirty- One dollars and seventy-six cents

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, THAT

Section One: The Mayor is hereby authorized to accept funding from the Federal Reserve Bank of Atlanta as reimbursement for services rendered.

Section Two: These funds are designated for use by PAL to continue their operations and to conduct athletic programs for youth in the City of Atlanta.
