AN ORDINANCE TO EXTEND THE SANITARY SERVICE FEE PAYMENT DUE DATE FROM SEPTEMBER 15, 2001 TO OCTOBER 15, 2001; TO PROVIDE THAT NO LATE PAYMENT FEES OR PENALTIES SHALL BE ASSESSED AGAINST A PROPERTY OWNER FOR PAYMENTS RECEIVED ON OR BEFORE OCTOBER 15, 2001; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, City of Atlanta is charged with the responsibility of the removal of garbage and other solid waste; and

WHEREAS, a Sanitary Service fee is assessed against the property owners; and

WHEREAS, this fee is based on a base fee plus an additional per frontage foot amount; and

WHEREAS, for many years Fulton County has been collecting this fee in conjunction with the City's ad valorem taxes; and

WHEREAS, the City has begun its own billing and collection process; and

WHEREAS, payment is due in full by September 15, 2001; and

WHEREAS, this will cause some hardship on some property owners.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1: The payment due date for 2001 Sanitary Service fees shall be extended



from September 15, 2001 to October 15, 2001 so that no late payment fees or penalties shall be assessed against property owners for payments received on or before October 15, 2001.

SECTION 2: All ordinances or part of ordinances in conflict herewith are hereby repealed.




