**A RESOLUTION AUTHORIZING PAYMENT IN THE  
AMOUNT OF \$2,775.00 IN SETTLEMENT OF THE CLAIM  
OF DELOIS R. JACKSON AGAINST THE CITY OF  
ATLANTA**

**WHEREAS**, Delois R. Jackson has filed a claim against the City of Atlanta seeking damages arising out of several occurrences of sewer back ups to her property located at 828 Delmar Court, SE; and

**WHEREAS**, the property owned by Delois R. Jackson has been damaged due to several occurrences of sewer back ups due to a blockage in the mainline which the City had knowledge of prior to the overflow which occurred on or about July 24, 2000, specifically; and

**WHEREAS**, the City of Atlanta was on notice of said nuisance and yet the City failed to abate said nuisance; and

**WHEREAS**, inasmuch as the facts disclosed indicate said claim is not based on a claim of negligence, but is a nuisance which is not subject to a defense of sovereign immunity under the laws of the State of Georgia; and

**WHEREAS**, the claimant has asserted damages in the amount of \$2,775.00 and has agreed to accept this sum in full and complete satisfaction and settlement of her claim against the City of Atlanta; and

**WHEREAS**, the City Attorney has recommended that the claim of Delois R. Jackson be settled for the sum of \$2,775.00.

**THEREFORE, BE IT RESOLVED** by the Council of the City of Atlanta, Georgia that \$2,775.00 be paid by the City of Atlanta in satisfaction of any and all claims Delois R. Jackson owner of property located at 828 Delmar Court, SE may have stemming from damages sustained to her property on or about July 24, 2000.

**BE IT FURTHER RESOLVED** that the Chief Financial Officer be and hereby authorized to pay the above mentioned sum from account number 2J01/529017/T31001.




which occurred on or about the 24<sup>th</sup> day of July, 2000,




