Section 3: All resolutions and parts of resolutions in conflict herewith be and the same are hereby repealed.

A SUBSTITUTE ORDINANCE
BY FULL COUNCIL

AN ORDINANCE TO AUTHORIZE THE MAYOR TO ACCEPT PRIVATE DONATIONS ON BEHALF OF THE CITY OF ATLANTA TO SUPPORT THE UPCOMING NATIONAL LEAGUE OF CITIES CONFERENCE IN ATLANTA; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") will serve as the host city for the upcoming National League of Cities ("NLC") Conference and, as the host, is responsible for the strategic management of the conference and various events; and

WHEREAS, the City will receive private donations from various organizations to support NLC activities including the planning, organizing and implementation of the 2001 NLC Conference; and

WHEREAS, donations received from the fund-raising campaigns will be deposited into an interest bearing Trust Account of the City; and

WHEREAS, it is in the best interest of the City to support activities for the NLC Conference.

THEREFORE, IT IS ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA:

SECTION 1: That the 2001 National League of Cities Conference will be held in Atlanta December 4-8, and the City will serve as the host city of the Conference.



SECTION 2: That the Mayor or his designee is authorized to accept donations or grants on behalf of the City to support the 2001 Conference and other specific NLC activities.

SECTION 3: That the Mayor or his designee is authorized to execute appropriate contractual agreements with National League and other entities in furtherance of Conference activities.

SECTION 4: That no part of the funds donated may be used for political activities.

SECTION 5: That the donated funds are not to be used for private purposes.

SECTION 6: That donors may be identified as supporters or contributors to the 2001 National League of Cities Conference.

SECTION 7: That all revenue received from private donations for NLC Conference activities shall be deposited into a City interest bearing Trust Fund Account and Center Number: **3P02 664101 D11W02CWQNAO.**

SECTION 8: That expenses incurred for the 2001 National League of Cities Convention shall be expended from City Trust Account and Center Numbers: **3P02 529002 D11W02CWQNAO.**

SECTION 9: That the Mayor or his designee is authorized to execute all documents necessary to accomplish acceptance of any donation to support the 2001 NLC Conference.
