



**A SUBSTITUTE ORDINANCE  
BY FINANCE/EXECUTIVE COMMITTEE**

AN ORDINANCE TO REPEAL ORDINANCE# 00-0-0724 ADOPTED ON JUNE 5, 2000 AND APPROVED BY THE MAYOR ON JUNE 13, 2000 THAT AUTHORIZED THE MAYOR TO ACCEPT TWO GRANTS FROM THE ATLANTA REGIONAL COMMISSION (ARC) TO CONDUCT SEPARATE ACTIVITY CENTERS/TOWN CENTERS INVESTMENT POLICY STUDIES (ACTIPS) FOR THE WEST END MARTA STATION AREA AND THE GREENBRIAR MALL COMMERCIAL AREA; ANTICIPATING AND APPROPRIATING RECEIPTS IN THE INTERGOVERNMENTAL GRANT FUND BUDGET IN THE AMOUNT OF \$136,000. THE GRANTS REQUIRE MATCHING FUNDS OF \$17,000 EACH TO BE PAID FROM 1C28 524001 Y63Q06129991 & 1C28 524001 Y63Q06139991 RESPECTIVELY; AND FOR OTHER PURPOSES.

WHEREAS, Ordinance 00-O-0724 adopted on June 5, 2000 and approved by the Mayor on June 5, 2000 needs to be repealed in its entirety as the legislation adopted on the above reflected dates was inaccurate; and

WHEREAS, the City of Atlanta has received two grants from the Atlanta Regional Commission to conduct separate Activity Centers/Town Centers Investment Policy Studies (ACTIPS) for the West End MARTA station area and the Greenbriar Mall commercial area; and

WHEREAS, the studies will prepare development alternatives for underutilized or vacant property, examine and propose alternatives for the enhancement of redevelopment land served by existing infrastructure, employment opportunities, and the encouragement of focused infill projects, and


WHEREAS, each grant is awarded for a total of \$68,000 and the City is requested to provide matching funds of \$17,000 per project, to complete the transportation infrastructure investment agreement, and

WHEREAS, the Budget Commission of the City of Atlanta has recommended increasing estimated receipts in the Intergovernmental Grant fund budget by \$136,000.00

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1:** That Ordinance 00-00724 adopted on June 5, 2000 and approved by the Mayor on June 13, 2000 be and is hereby repealed

**Section 2:** That the 2001 General Government Capital Outlay Fund Department of Public Works is hereby amended as follows:
