**AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO INSTALL STOP SIGNS ALONG THE INTERSECTIONS OF WEST LAKE AVENUE, NW, AND FOR OTHER PURPOSES.**

**WHEREAS**, there is an increasingly growing number of vehicles that are traveling through the intersections of West Lake Avenue, NW; and

**WHEREAS**, there are many families in the area which households run the gambit of senior citizens to elementary age children; and

**WHEREAS**, residents of the neighborhood in the area surrounding West Lake Avenue, NW have expressed their concerns regarding the high volume of traffic that comes through this intersection due, in large measure to the accessibility of Martin Luther King, Jr. Drive and the I-20 Interchange; and

**WHEREAS**, there is an elementary and middle school (Anderson Park and Turner) and a park in the area which places school buses and children traveling up and down the street in the morning where vehicles are trying to get to the freeway; and

**WHEREAS**, the lack of a stop signs poses a significant hazard and public safety risk to all the residents of the neighborhood.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA** as follows:

**SECTION 1:** That Stop Signs shall be installed along West Lake Avenue, NW at the following intersections Calloway Drive, Tiger Flowers Drive, and Ezra Church Road, NW.

**SECTION 2:** That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
