**AN ORDINANCE

**AN ORDINANCE REGULATING THE SPEED LIMIT ON OLD IVY ROAD, N.E.
AT 25 MILES PER HOUR**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
ATLANTA, as follows:**

Section 1. That the Speed Limit on the following street within the City of Atlanta be made 25 MILES PER HOUR.

Old Ivy Road, N.E. from Wieuca Road to Roswell Road

Section 2. That all said speed limits as herein established shall be and become effective upon the approval of this ordinance, provided that appropriate signs in accordance with said law are erected and in place giving notice to the public that such speed limits have been established. Such speed limits shall not be effective in any such areas, however, until and unless such appropriate signs are properly erected.

Section 3. That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
