**A SUBSTITUTE ORDINANCE  
BY FINANCE/EXECUTIVE COMMITTEE**

**AMENDING THE 2001 (1996 AND 1997 BOND FUNDS) BUDGETS IN THE AMOUNT OF \$50,000.00 EACH (\$100,000.00 TOTAL) TO PROVIDE FOR THE CITY OF ATLANTA'S SHARE OF DEVELOPMENT COST OF THE TECHWOOD DRIVE POLICE MINI-PRECINCT; AND FOR OTHER PURPOSES.**

**WHEREAS**, as part of the Centennial Place redevelopment, Techwood Park Incorporated solicited and received contributions from various entities to construct the Techwood Drive Police Mini-Precinct; and

**WHEREAS**, the City's share of the development in the amount of \$100,000.00 is still outstanding; and

**WHEREAS**, this facility was completed and dedicated to two fallen police officers in May of 1999 and has been occupied by the Police Department since that time.

**NOW, THEREFORE BE IT ORDAINED** by the Council of the City of Atlanta, Georgia, as follows:

**SECTION 1:** That the 2001 (1996 and 1997 General Obligation Bond Fund) budgets be and are hereby amended as follows:


Dear Mr. Grant:

As a follow-up on our conversation this afternoon, I am sending a second request for the fulfillment of Mayor Bill Campbell's commitment for financial support of the Techwood Drive Police Mini-Precinct. This commitment was made to Mr. John Aderhold, Vice Chairman of Techwood Park, Inc. in the Spring of 1995. Mr. Aderhold has worked diligently to support the Mayor's efforts to promote and implement redevelopment along Techwood Drive and has been involved in several other redevelopment projects in the City. With the Mayor's support of this public/private partnership he made possible the success of many initiatives for positive change in Atlanta including the recently announced Centennial Market Retail Center.

The Police Precinct was completed and dedicated to two fallen police officers in May of 1999. The City of Atlanta's Police Department has occupied it since.

The City's commitment of \$100,000 made the development of the 1.6 million dollar Techwood Drive Police Mini-Precinct a reality. However, all commitments public and private made to this project have been collected except for the outstanding amount from the City of Atlanta. I have attached the latest funding update, which shows all commitments made to the project.


