**WHEREAS**, the City of Atlanta did solicit bids for FC-7258-00, CPTC Cosmetics, on behalf of the Department of Aviation; and

**WHEREAS**, the General Manager of the Department of Aviation and the Director of the Bureau of Purchasing and Real Estate have recommended that contract FC-7258-00, CPTC Cosmetics, be awarded to the lowest, most responsible and most responsive bidder, Paramount Contracting Company; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor be and is hereby authorized to enter into an appropriate contractual agreement with Paramount Contracting Company for FC-7258-00, CPTC Cosmetics, on behalf of the Department of Aviation, for a total not to exceed amount of \$818,500.00.

**BE IT FURTHER RESOLVED**, that the Director of the Bureau of Purchasing and Real Estate be and is hereby directed to prepare an appropriate contractual agreement for execution by the Mayor, to be approved by the City Attorney as to form.

**BE IT FURTHER RESOLVED**, that this agreement shall not become binding on the City and the City shall incur no liability upon same until such contract has been executed by the Mayor and delivered to the contracting party.

**BE IT FINALLY RESOLVED**, that all contracted work shall be charged to and paid from Fund Account and Center Number: 2H27 574001 R21E00693CG.
