AN ORDINANCE

AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO MODIFY THE BOUNDARIES OF THE INMAN PARK AND PONCEY HIGHLANDS NEIGHBORHOODS AND TO AMEND THE CITY'S OFFICIAL NEIGHBORHOOD MAP ACCORDINGLY; AND FOR OTHER PURPOSES.

WHEREAS Resolution 93-R-0058, adopted by the City Council on March 1, 1993, and approved by the Mayor on March 8, 1993, authorized the Mayor or his designee to publish the City's official neighborhood map, entitled "Planning Units for Atlanta's Neighborhoods"; and

WHEREAS City Code Section 6-3012 defines "neighborhood" as "...a geographic area either with distinguishing characteristics in which the residents have a sense of identity and commonality of perceived interest, or both", and

WHEREAS said Section identifies various factors that may contribute to neighborhood identity, including "shared development, history, architecture, social and economic relationships, physical boundaries, and the existence of one or more broadly representative neighborhoods organizations devoted to neighborhood preservation and improvement", and

WHEREAS the residents of Inman Park seek to preserve and enhance their neighborhood by revising their boundaries to include additional properties directly associated by geographic proximity to Inman Park, and

WHEREAS the area formerly belonged to the Poncey Highlands neighborhood, but is now separated from Poncey Highlands by Freedom Parkway, and

WHEREAS the Inman Park and Poncey Highlands official neighborhood organizations have agreed that area described in their Memorandum of Understanding, dated September 27, 2001 should be now be incorporated into the Inman Park neighborhood, and

WHEREAS the Commissioner of Planning, Development and Neighborhood Conservation is in agreement with this request, and

WHEREAS the City Council has agreed to amend the official City neighborhood map;

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1. The City Council hereby agrees to amend the City's official neighborhood boundaries of the Inman Park and Poncey Highlands neighborhoods, as shown on the attached exhibits. The City Council authorizes the Mayor or his designee to amend the City's official neighborhood map accordingly.

Section 2. All ordinances and portions of ordinances in conflict herewith are hereby rescinded.

Boundary Amendment for Inman Park and Poncey Highlands Neighborhoods





MEMORANDUM OF UNDERSTANDING

Subject: Inman Park Neighborhood Boundaries

This Memorandum of Understanding (MOU) serves as notice to the NPU-N neighborhoods and the City of Atlanta that Inman Park and Poncey Highlands agreed in 1997 that the following are the revised boundaries of the Inman Park neighborhood:

1. Starting with the intersection of Moreland Avenue and the Georgia Railroad Line and proceeding in a clockwise manner along Georgia Railroad line west to the Southern Railroad Line,
2. then continuing north on the Southern Railroad Line to the southern edge of the eastbound lane of Freedom Parkway,
3. then continuing east along the southern lane of Freedom Parkway to Moreland Avenue, and
4. then continuing south along the center line of Moreland Avenue to the Georgia Railroad Line which is the originating point of the boundary.
