AN ORDINANCE AMENDING SECTION 130-84 OF THE ATLANTA CITY CODE OF ORDINANCES TO PROVIDE FOR A MAXIMUM CAP OF 200 FEET ON STREET FRONTAGE FOR PAVED AND UNPAVED STREETS FOR CALCULATING THE RESIDENTIAL RATE FOR RUBBISH COLLECTION COSTS.

WHEREAS, the City of Atlanta's sanitary service fees include charges that are based on the street frontage of properties; and

WHEREAS, Ordinance 00-O-1626 amended the way the City calculates rubbish collection costs for paved and unpaved frontage by measuring the frontage exactly rather than by "each 25 feet or fraction thereof."

WHEREAS, Ordinance 00-O-1626 also amended the code by eliminating the 200 feet maximum cap of street frontage for paved and unpaved streets for calculating the residential rate for rubbish collection costs.

WHEREAS, the sanitary service fee for many citizens has been increased dramatically by elimination of the 200-foot cap.

**WHEREAS, it is the desire of the Atlanta City Council to correct the error of the elimination of the 200 foot cap in the residential rates for rubbish collection.**

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA that Section 130-84 be amended as follows:

**SECTION 1: That Sec. 130-84. Rates and charges, paragraph (1) be amended as follows:**

(1) Residential rate: \$208.59 per year plus .94 cents per foot of paved street frontage and, to cover rubbish collection costs for unpaved frontage, .67 cents per foot of unpaved street frontage, up to a maximum of 200 feet. In calculating the charge, paved frontage is calculated first and then unpaved frontage.

**SECTION 2:** That this amendment shall be put in place for the year 2001 billing cycle of the sanitary service fees.

**SECTION 3:** That all ordinances or parts of ordinances in conflict herewith are hereby repealed.


