DEVELOPMENT AND NEIGHBORHOOD CONSERVATION TO  
CONDUCT THE HOSEA WILLIAMS COMMERCIAL CORRIDOR  
STUDY IN CONJUNCTION WITH THE KIRKWOOD COMMUNITY  
AND KIRKWOOD COMMUNITY TASK FORCE.**

Whereas, the Hosea Williams Drive Commercial District is in need of revitalization and redevelopment and,

Whereas, the Hosea Williams Drive Commercial District and surrounding neighborhoods are currently developing and implementing plans for said revitalization and,

Whereas, further development activity has the potential to create a popular destination due to the areas' intimate scale, historic structures and traditional neighborhood design and,

Whereas, it is the intent of the Task Force and The City to enhance the appearance and economic vitality of the Commercial District by creating safe, adequate and attractive pedestrian space, better access for vehicular, bicycle and transit needs, and a well designed economic strategy to support existing and future development and,

Whereas, it is the intent of the Task Force and The City to preserve the existing character of the Commercial Corridor and provide design intervention which is coordinated with surrounding neighborhood design, pedestrian, transportation and zoning characteristics and,

Whereas, the design components for the corridor will focus on the creation of a signature image and include typical treatments for building facades, transportation enhancements, sidewalks, streetscapes, signage, lightning and other public realm improvements.

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
ATLANTA, GEORGIA, that the Kirkwood Community Task Force, the Department of  
Planning, Development and Neighborhood Conservation and the Atlanta Development  
Authority (ADA) are hereby requested to conduct the Hosea Williams Commercial  
Corridor Study from Warren Street to Douglas Street including but not limited to  
economic development, transportation planning, streetscape enhancements, and  
sidewalk construction improvements.**
